## WESTERN UNDERGRADUATE EXCHANGE PROGRAM (WUE)

The Western Undergraduate Exchange (**WUE**) is a program of the Western Interstate Commission of Higher Education (WICHE). Through WUE, students in the western states may enroll in many two-year and four-year college **degree** programs at a reduced tuition level: 150 percent of the institution's regular resident tuition. WUE tuition is considerably less than nonresident tuition.

### The following states participate in the WUE program along with Nevada:

Alaska    Arizona    California    Colorado    Hawaii    Idaho    Montana    New Mexico    North Dakota  
Oregon    South Dakota    Utah    Washington    Wyoming    Commonwealth of Northern Marianas Islands

Only newly admitted students who are in a degree seeking program are eligible to apply. The WUE application process must be completed before the student is in attendance at Nevada State College. Applicants must have maintained a legal bona fide resident status in an approved WUE state for at least 12 months prior to the first day of the term of application. An applicant must also be a U.S. citizen or Resident Alien.

**Requirements:** Official high school transcripts indicating the student's graduation from a high school in one of the participating WUE states listed above, official proof of WUE residency at one of the NSHE institutions, OR **any two** of the following:

- Driver's license or state identification card issued in one of the WUE states at least 12 months immediately prior to the date of application to NSC.
- Federal/state income tax return (for the most recent tax year) indicating a WUE state address.
- Proof of employment in one of the WUE states for at least 12 months immediately prior to the date of application to NSC.
- Utility bills in one of the WUE states for at least 12 months immediately prior to the date of application to NSC.
- Vehicle registration issued in one of the WUE states at least 12 months immediately prior to the date of application to NSC.
- Voter registration card issued in one of the WUE states at least 12 months immediately prior to the date of application to NSC.
- Lease or rent receipts in one of the WUE states for at least 12 months immediately prior to the date of application to NSC.
- Ownership or mortgage receipts for a house in one of the WUE states for at least 12 months immediately prior to the date of application to NSC.
- Payment of property taxes in one of the WUE states for 12 months immediately prior to the date of application to NSC.

**Students who are approved for WUE status and enroll may not be reclassified as a Nevada resident until the student disenrolls from the WUE program and pays full nonresident tuition for at least 12 months from reclassification.**
