## UNDERGRADUATE TUITION AND FEES FOR ACADEMIC YEAR 2020 – 2021 (Summer 2020, Fall 2020, & Spring 2021)

### MANDATORY UNDERGRADUATE ENROLLMENT FEES

• Registration Fees, NSC (Undergraduate level courses)	\$175.00 per credit
• Technology Fee	\$7.50 per credit
• Student Success Fee	\$5.00 per credit
• Surcharge Fee	\$5.00 per credit

### OTHER ENROLLMENT FEES (Applicable rates are assessed in addition to mandatory enrollment fees)

• Distance Education Fee (hybrid and online classes only)	\$25.00 per credit
• Differential Fee (All 100-499 level Nursing courses. Not applicable to RN to BSN Program)	\$175.00 per credit
• Summer School Registration Surcharge (Summer term only)	\$3.00 per credit
• Excess Credit Fee (50 percent Excess Credit Fee on the per-credit registration fee shall be charged to a student who has accrued attempted credits equal to 150 percent of the credits required for the student's program of study.)	\$87.50 per credit
• Special Building Fee (Fall and Spring Semester terms only. Applies if enrolled in 4 or more credits. Not applicable to RN to BSN Program)	\$150.00 per semester
• Special Course Fee and/or Lab fees (Please refer to the College Catalog)	Varies

### NON-RESIDENT TUITION RATES (Applicable rates are assessed in addition to mandatory enrollment fees. Fall and Spring Semester terms only.)

• Full-time Non-resident Tuition (Full-time non-resident tuition rates are assessed to students enrolled in 7 or more credits)	\$6,500.50 per semester
• Part-time** Non-resident Tuition, (Undergraduate level courses. Part-time non-resident tuition rates are assessed to students enrolled in fewer than 7 credit)	\$192.50 per credit
• WUE Tuition, NSC (Undergraduate level )	\$87.50 per credit
• Distance Tuition Rate (Assessed only to non-resident students who are residing outside of Nevada during the semester in which enrollment in the distance education course(s) occurs. Undergraduate & Post baccalaureate level courses)	\$87.50 per credit
• RN to BSN Registration Fee, NSC (Flat Rate only, All terms)	\$247.22 per credit

• Admissions Application fee (Undergraduate applications non-refundable)	\$30.00
• Transcript Fee (Additional fees may apply for expedited requests, see catalog)	\$3.00
• Service Charge for Non-Sufficient Funds Checks	\$25.00
• Student Identification Card Fee	\$5.00
• Student Identification Card Replacement Fee	\$5.00
• Late Installment fee	\$10 minimum or 10% of amount due
• Payment Plan Fee	\$25.00 per payment plan

You will receive a supplemental invoice for any additional amounts which the Board of Regents may impose. Fee changes put in place less than 30 days before commencement of classes will not be subject to late fee penalties.
